 Verification of business and personal biographical, legal and financial information (including copies of each of the following):
 - o 2013 Full Year and 2014 YTD balance sheets
 - o 2013 Full Year and 2014 YTD income / profit & loss statement
 - Legal entity certification (one of the following: documentation of legal entity, business certification form, or Articles of Incorporation)
 - o 2013 business federal tax return*
 - o Proof of business ownership percentage**
 - o Business owner's driver's license, or both a state/national ID and his/her passport

*2012 federal tax returns can be submitted if the applicant filed for an extension on the 2013 returns for the business. Along with 2012 returns, the applicant should submit: 1) Federal Extension form and 2) 2012 financial statements (balance sheet and income / profit & loss statement), in addition to the above materials.

**Common submissions include: stock certificate, Schedule B (filed with Form 1065), Schedule E (filed with Form 1120), Schedule K-1 (filed with Form 1065 or Form 1120-S)
